14		membership and adoption applications misspelled or incorrectly listed the			
15		names and/or date of birth of members; and			
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 27-84, 138-87, 98-123,			
17		04-212, 04-350, 05-054, 05-711, 06-787, 07-075, and 21-088 be amended to reflect			
18		the correct names and/or date of birth of members identified in the August 2022
