

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Sells District Economic Development Committee Enterprise
Renovations Budget Amendment No. 1)**

RESOLUTION NO. 22-261

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022 Sells District Economic Development Committee Enterprise
13 Renovations Budget in the amount of \$484,934.00 was authorized by Sells District
14 Council Resolution SD-123-21 and approved by Legislative Council Resolution No.
15 22-024; and

16 **WHEREAS,** by Sells District Council Resolution No. SD-60-22, the Sells District has authorized
17 and submitted for review and approval its FY 2022 Sells District Economic
18 Development Committee Enterprise Renovation Budget Amendment No. 1, which
19 is incorporated by this reference and which will extend the FY 2022 Sells District
20 Economic Development Committee Enterprise Renovation Budget until
21 September 30, 2023; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Sells District
23 Economic Development Committee Enterprise Renovations Budget Amendment
24 No. 1 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2022 Sells District Economic Development Committee Enterprise Renovations
27 Budget Amendment No. 1, which does not change the budget amount of
28 \$484,934.00, but does extend the budget from October 1, 2021 to September 30,
29 2023.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Sells District FY
31 2022 Sells District Economic Development Committee Enterprise Renovations
32 Budget, as amended shall be managed and expended in accordance with Article

IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


