12	WHEREAS,	by Gu Achi District Council Resolution No. 1221-064, the Gu Achi District has
13		authorized the FY 2022-2024 American Rescue Plan Act Budget, which is
14		incorporated by this reference, in the amount of \$3,570,716.00; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2022-2024 Gu Achi
16		District American Rescue Plan Act Budget and recommends its approval.
17	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2022-2024 Gu Achi District American Rescue Plan Act Budget in the amount of
19		\$3,570,716.00 effective October 1, 2021 through December 31, 2024, which shall be
20		funded by the Tohono O'odham Nation American Rescue Plan Act funds pursuant
21		to Resolution No. 21-292.
