

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Judicial Branch Budget)**

RESOLUTION NO. 22-267

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Judicial Branch has prepared and submitted for**
8 **review and approval its FY 2023 Judicial Branch Budget, which is incorporated by**
9 **this reference, in the amount of \$7,948,077.98 to be funded from the Nation's**
10 **general fund; and**


11 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2023**
12 **Judicial Branch Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2023 Judicial Branch Budget effective October 1, 2022, in the amount of**
15 **\$7,948,077.98, which shall be funded by the Nation's general fund.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Nation Chief Judge or any designated official is authorized to administer and**
18 **expend the FY 2023 Judicial Branch Budget, provided that any amendments or**
19 **modifications shall be submitted for prior approval by the Tohono O'odham**
20 **Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
22 **day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,**
24 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**






