

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Natural Resources Rodeo and Fair  
Revenue Funding Budget)**

**RESOLUTION NO. 22-280**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Natural Resources has prepared and submitted for review and  
8 approval its FY 2023 Rodeo and Fair Revenue Funding Budget, which is  
9 incorporated by this reference, in the amount of \$455,466.06 of which \$405,466.06  
10 is to be funded from the Nation's general fund, and \$10,000.00 is funded from  
11 donations and contributions and \$40,000.00 is funded from the program  
12 revenue; and

13 **WHEREAS,** the portion of the FY 2023 Rodeo and Fair Budget in the amount of \$405,466.06  
14 which shall be funded from the Nation's general fund is addressed by a separate  
15 resolution; and

16 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees  
17 have reviewed the FY 2023 Department of Natural Resources Rodeo and Fair  
18 Revenue Funding Budget and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2023 Department of Natural Resources Rodeo and Fair Revenue Funding  
21 Budget effective October 1, 2022, in the amount of \$50,000.00 of which the amount  
22 of \$10,000.00 shall be funded from donations and contributions and \$40,000.00  
23 shall be funded from program revenue.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2023 Department of Natural Resources Rodeo and Fair Revenue  
27 Funding Budget, provided that any amendments or modifications shall be  
28 submitted for prior approval by the Tohono O'odham Legislative Council.


