

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Natural Resources Reburial Ceremony Budget)**

RESOLUTION NO. 22-281

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
8 **approval its FY 2023-FY 2027 Department of Natural Resources Cultural Affairs**
9 **Reburial Ceremony Budget, which is incorporated by this reference, in the**
10 **amount of \$17,500.00 to be funded from surplus funding; and**

11 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
12 **FY 2023-FY 2027 Department of Natural Resources Cultural Affairs Reburial**
13 **Ceremony Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2023-FY 2027 Department of Natural Resources Cultural Affairs Reburial**
16 **Ceremony Budget effective October 1, 2022 in amount of \$17,500.00, which shall**
17 **be funded by surplus funding provided that:**

- 18 1. **The base budget amount for each fiscal year shall be \$3,500.00**
- 19 2. **Funds that are not expended in a given fiscal year shall be carried over and**
20 **may be expended in the following year.**
- 21 3. **The budget will continue to be administrated by the Cultural Affairs Office.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2023-FY 2027 Department of Natural Resources Cultural Affairs**
25 **Reburial Ceremony Budget, provided that any amendments or modifications**
26 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
