

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Health and Human Services Women,  
Infants, and Children Program Inter Tribal Council of Arizona Grant Budget)**

**RESOLUTION NO. 22-294**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2023 Women, Infants, and Children Program ("WIC")  
9 Grant Budget, which is incorporated by this reference, in the amount of  
10 \$129,540.00 to be funded by the Nation's general fund pending reimbursement by  
11 the grantor, the Inter Tribal Council of Arizona; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
13 reviewed the FY 2023 Department of Health and Human Services Women, Infants,  
14 and Children Program Inter Tribal Council of Arizona Grant Budget and  
15 recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2023 Department of Health and Human Services Women, Infants, and Children  
18 Program Inter Tribal Council of Arizona Grant Budget effective October 1, 2022 in  
19 the amount of \$129,540.00, which shall be funded by the Nation's general fund  
20 pending reimbursement by the grantor, the Inter Tribal Council of Arizona.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2023 Department of Health and Human Services Women, Infants,  
24 and Children Program Inter Tribal Council of Arizona Grant Budget, provided  
25 that any amendments or modifications shall be submitted for prior approval by  
26 the Tohono O'odham Legislative Council.

27 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>  
28 day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-  
29 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,  
30 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
33 18, 1934 (48 Stat.984).
