

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Executive Branch Tribal Budgets)**

RESOLUTION NO. 22-295

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
8 2023 Executive Branch Tribal Budgets, which is incorporated by this reference, in
9 the amount of \$108,784,724.98 to be funded from the Nation's general fund; and


10 **WHEREAS,** the designated oversight committees for the respective departments and
11 programs and Budget and Finance Committee have reviewed the FY 2023
12 Executive Branch Tribal Budgets and recommend its approval.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
14 FY 2023 Executive Branch Tribal Budgets effective October 1, 2022 in the amount
15 of \$108,784,724.98, which shall be funded by the Nation's general fund.

16 **RE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
17 Nation chairperson or any designated official is authorized to administer and
18 expend the FY 2023 Executive Branch Tribal Budgets, provided that any
19 amendments or modifications shall be submitted for prior approval by the
20 Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH
22 day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-
23 AGAINST; 556.5[01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council
24 by, Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted
25 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
26 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
27 Act of June 18, 1934 (48 Stat.984).




