

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Community
Health Budget Amendment No. 1)

RESOLUTION NO. 22-299

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Community Health
8 Budget in the amount of \$2,269,150.00 was approved by Resolution No. 21-325;
9 and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2022 Community Health Budget Amendment No. 1,
12 which is incorporated by this reference, and will adjust operational and/or
13 personnel line items; and

14 **WHEREAS,** the FY 2022 Department of Health and Human Services Community Health
15 Budget Amendment No. 1 will not change the budget amount of \$2,269,150.00; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2022 Department of Health and Human Services Community
18 Health Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2022 Department of Health and Human Services Community Health Budget
21 Amendment No. 1 effective October 1, 2021, which does not change the budget
22 amount of \$2,269,150.00 and shall be funded by the Self- Governance Funding
23 Agreement.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2022 Department of Health and Human Services Community
27 Health Budget as amended, provided that any amendments or modifications
28 shall be submitted for prior approval by the Tohono O'odham Legislative Council.
