

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services
Division of Child Welfare Budget Amendment No. 1)**

RESOLUTION NO. 22-301

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Division of Child Welfare
8 Budget in the amount of \$6,536,479.51 was approved by Resolution No. 21-324;
9 and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2022 Division of Child Welfare Budget Amendment
12 No.1, which is incorporated by this reference, which will increase by \$271,099.41
13 from \$6,536,479.51 to \$6,807,578.92 to be funded by the Nation's General Fund;
14 and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
16 reviewed the FY 2022 Department of Health and Human Services Division of Child
17 Welfare Budget Amendment No.1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2022 Department of Health and Human Services Division of Child Welfare
20 Budget Amendment No. 1 effective October 1, 2021 in the amount of \$6,807,578.92
21 which shall be funded by the Nation's General Fund.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2022 Department of Health and Human Services Division of Child
25 Welfare Budget Amendment No. 1, provided that any amendments or
26 modifications shall be submitted for prior approval by the Tohono O'odham
27 Legislative Council.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
29 **day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ARSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
