

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Chukut Kuk District Ston Sudagi Community, San Miguel
Community, and Williams Ranch Community Budget Amendments No. 1 and
FY 2022 Chukut Kuk District Budget Amendment No. 2)**

RESOLUTION NO. 22-310

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2022 Chukut Kuk District Budget in the amount of \$2,521,338.20 was
13 authorized by Chukut Kuk District Council Resolution No. 2021-38 and approved
14 by Legislative Council Resolution No. 21-367 and subsequently amended by
15 Resolution No. 22-075; and

16 **WHEREAS,** by Chukut Kuk District Council Resolution Nos. 2022-16, 2022-23 and 2022-24, the
17 Chukut Kuk District has authorized and submitted for review and approval its FY
18 2022 Chukut Kuk District Ston Sudagi Community Budget Amendment No. 1, FY
19 2022 San Miguel Community Budget Amendment No. 1 and the FY 2022 Williams
20 Ranch Community Budget Amendment No. 1, which are incorporated by these
21 references and which will adjust operational and/or personnel line items; and

22 **WHEREAS,** the FY 2022 Ston Sudagi Community Budget Amendment No. 1 will increase the FY
23 2022 Ston Sudagi Community Budget by \$35,804.71 from \$20,000.00 to \$55,804.71;
24 and

25 **WHEREAS,** the FY 2022 San Miguel Community Budget Amendment No. 1 will increase the FY
26 2022 San Miguel Community Budget by \$36,978.16 from \$40,000.00 to \$76,978.16;

28 **WHEREAS,** the FY 2022 Williams Ranch Community Budget Amendment No.1 will increase
29 the FY 2022 Williams Ranch Community Budget by \$40,530.92 from \$20,000.00 to
30 \$60,530.92; and

1 **WHEREAS, the FY 2022 Chukut Kuk District Budget Amendment No. 2 will incorporate the FY**
2 **2022 Ston Sudagi Community, San Miguel Community, and Williams Ranch**
3 **Community Budget Amendments No. 1 and will increase the FY 2022 Chukut Kuk**
4 **District Budget by \$113,313.79 from \$2,552,840.56 to \$2,666,154.35; and**

5 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Chukut Kuk District**
6 **Ston Sudagi Community, San Miguel Community, and Williams Ranch**
7 **Community Budget Amendments No. 1 and the FY 2022 Chukut Kuk District**
8 **Budget Amendment No. 2 and recommends approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
10 **FY 2022 Chukut Kuk District Ston Sudagi Community, San Miguel Community,**
11 **and Williams Ranch Community Budget Amendments No. 1 that shall be funded**
12 **as follows:**

- 13 1. **FY 2022 Ston Sudagi Budget Amendment No. 1 which includes a \$35,804.71**
14 **increase from \$20,000.00 to \$55,804.71 that shall be funded from FY 2020**
15 **and FY 2021 carry over funds;**
- 16 2. **FY 2022 San Miguel Community Budget Amendment No. 1 which includes**
17 **a \$36,978.16 increase from \$40,000.00 to \$76,978.16 that shall be funded**
18 **from FY 2021 carry over funds; and**
- 19 3. **FY 2022 Williams Ranch Community Budget Amendment No. 1 which**
20 **includes a \$40,530.92 increase from \$20,000.00 to \$60,530.92 that shall be**
21 **funded from the following sources:**
 - 22 a. **FY 2016 carryover in the amount of \$5776.79;**
 - 23 b. **FY 2020 carryover in the amount of \$15,615.36;**
 - 24 c. **FY 2021 carryover in the amount of \$13,380.73;**
 - 25 d. **FY 2014 Mining in the amount of \$3,226.01; and**
 - 26 e. **FY 2016 Mining in the amount of \$2,532.03.**

27 **NOW, THEREFORE, RE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council**
28 **approves the FY 2022 Chukut Kuk District Budget Amendment No. 2, which**
29 **includes the FY 2022 Chukut Kuk District Ston Sudagi Community, San Miguel**
30 **Community, and Williams Ranch Community Budget Amendments No. 1**
31 **increases for a total of \$113,313.79 from \$2,552,840.56 to \$2,666,154.35.**



5 authorized under District Council resolution and submitted for prior approval by
6 the Tohono O'odham Legislative Council.


7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH

10 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
11 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
12 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
13 (48 Stat.984).




