**RESOLUTION NO. 22-316**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section I(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
14 **membership and adoption applications misspelled or incorrectly listed the**  
15 **names of members; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 83-83, 127-83, 40-84,**  
17 **70-88, 97-256, 99-039, 99-140, 01-263, 01-416, 01-449, 04-109, 04-659, 05-054, 05-**  
18 **114, 05-301, 06-002, 07-075, 07-546, 09-008, and 22-212 be amended to reflect the**  
19 **correct names for the members identified in the September 2022 Corrected**  
20 **Enrollment Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 83-83, 127-83, 40-84, 70-88, 97-256, 99-039, 99-140, 01-263, 01-416, 01-449, 04-**  
23 **109, 04-659, 05-054, 05-114, 05-301, 06-002, 07-075, 07-546, 09-008, and 22-212 are**  
24 **amended upon the effective date of those resolutions to reflect the correct names**  
25 **of members identified in the September 2022 Corrected Enrollment Resolution**  
26 **Summary.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
28 **day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**

30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**

32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
