

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 - FY2023 Department of Education Child Care and Development
Block Grant American Rescue Plan Act 2021 Public Law 117-002 Budget)

RESOLUTION NO. 22-322

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2022-FY2023 Child Care and Development Block Grant American**
9 **Rescue Plan Act (ARPA) 2021 Public Law (P.L.) 117-002 Budget, which is**
10 **incorporated by this reference, in the amount of \$7,595,872.00 to be funded from**
11 **the American Rescue Plan Act by the U.S. Department of Health and Human**
12 **Services Administration for Children and Families; and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committee have**
14 **reviewed the FY 2022-FY2023 Department of Education Child Care and**
15 **Development Block Grant ARPA 2021 P.L. 117-002 Budget and recommend its**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2022-FY2023 Department of Education Child Care and Development Block**
19 **Grant ARPA 2021 P.L. 117-002 Budget effective October 01, 2021 through**
20 **September 30, 2023, in amount of \$7,595,872.00, which shall be funded by the**
21 **American Rescue Plan Act by the U.S. Department of Health and Human Services**
22 **Administration for Children and Families.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2022-FY2023 Department of Education Child Care and**
26 **Development Block Grant ARPA 2021 P.L. 117-102 Budget, provided that any**
27 **amendments or modifications shall be submitted for prior approval by the**
28 **Tohono O'odham Legislative Council.**
