

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Education Tohono O'odham
ha Ma:mscama i he We:mta Budget)

RESOLUTION NO. 22-323

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2023 Tohono O'odham ha Ma:mscama i he We:mta Budget, which
9 is incorporated by this reference, in the amount of \$566,166.53 to be funded from
10 the Nation's General Fund; and


11 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
12 reviewed the FY 2023 Department of Education Tohono O'odham ha Ma:mscama
13 i he We:mta Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2023 Department of Education Tohono O'odham ha Ma:mscama i he We:mta
16 Budget effective October 1, 2022, in amount of \$566,166.53, which shall be funded
17 by the Nation's General Fund.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2023 Department of Education Tohono O'odham ha Ma:mscama i
21 he We:mta Budget, provided that any amendments or modifications shall be
22 submitted for prior approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,096.1 FOR;**
25 **121.9 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council**
26 **by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**
