14		reference in the amount of \$3,948,998.22; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2023 Hickiwan District
16		Budgets and recommends approval.
17	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2023 Hickiwan District Budgets effective October 1, 2022 in the amount of
19		\$3,948,998.22, which shall be funded by the August 2022 District Gaming
20		Allocation.
