2		appoint, or provide for the appointment of, and prescribe the duties and powers
3		of committees, boards, officers and agents" (Constitution of the Tohono O'odham
4		Nation, Article VI, Section 1(b)); and
5	WHEREAS,	the Tohono O'odham Nation's Elections law, codified at 12 Tohono O'odham Code
6		Chapter 1, authorizes the Tohono O'odham Legislative Council to appoint five
7		bilingual members of the Tohono O'odham Nation to the Nation's Election Board
8		(12 T.O.C. Chapter 1, Article III, Section 1301(A) and (B)); and
9	WHEREAS,	the Nation's Elections law provides that Election Board members shall be
10	·	"appointed for a term of five years or until their successors are appointed" and
11		further that "[a]ppointments to the [Election] Board shall be staggered so that the
12		term of office of only one member will end in any single year" (12 T.O.C. Chapter
13		1, Article III, Section 1301(B)); and
14	WHEREAS,	the Rules Committee recommends that Agnes Joaquin be appointed to the
15	,	Election Board for a term ending September 16, 2027.
16	NOW. THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints
17	1,011, 111111	Agnes Joaquin to the Election Board for a term beginning on the effective date of
18		this resolution and ending September 16, 2027, provided that she shall continue
