3		of committees, boards, officers and agents" (Constitution of the Tohono O'odham						
4		Nation, Article VI, Section 1(b)); and						
5	WHEREAS,	the Tohono O'odham Nation's Elections law, codified at 12 Tohono O'odham Code						
	WHEREAS,	Chapter 1, authorizes the Tohono O'odham Legislative Council to appoint five						
6		bilingual members of the Tohono O'odham Nation to the Nation's Election Board						
7								
8		(12 T.O.C. Chapter 1, Article III, Section 1301(A) and (B)); and						
9	WHEREAS,	the Nation's Elections law provides that Election Board members shall be						
10		"appointed for a term of five years or until their successors are appointed" and						
11		further that "[a]ppointments to the [Election] Board shall be staggered so that the						
12		term of office of only one member will end in any single year" (12 T.O.C. Chapter						
13		1, Article III, Section 1301(B)); and						
14	WHEREAS,	Camillus Lopez was appointed to the Election Board by Resolution No. 16-591 for						
15		a term ending July 31, 2021, and he continues to serve until his successor is						
16		appointed; and						
17	WHEREAS,	the Rules Committee recommends that Camillus Lopez be appointed to the						
18		Election Board for a term ending July 31, 2026.						
19	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints						
20	1	Camillus Lopez to the Election Board for a term beginning on August 1, 2021 and						
21		ending July 31, 2026, provided that he shall continue to serve until his successor						
22		is appointed.
