The management of these funds shall be only by 5 a treasurer or other authorized officer of the district council who has 6 furnished a surety bond satisfactory to the treasurer of the Tohono 7 O'odham Nation, and all expenditures of these funds shall be by checks 8 signed by such treasurer or other authorized officer and the chairman or 9 vice chairman of the district council. 10 : and 11 by Sells District Council Resolution No. SD-78-22, the Sells District has authorized 12 WHEREAS, the FY 2023 Sells District Gaming Revenue Budgets, which are incorporated by 13 these references in the amount of \$4,500,000.00; and 14 the Budget and Finance Committee has reviewed the FY 2023 Sells District 15 WHEREAS, Gaming Revenue Budgets and recommends approval. 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 FY 2023 Sells District Gaming Revenue Budgets effective October 1, 2022 in the 18 amount of \$4,500,000.00, which shall be funded by the Sells District Account with 19 Morgan Stanley Smith Barney. 20 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Sells 21 District Gaming Revenue Budgets shall be managed and expended in accordance 22 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and 23 the Nation's laws, provided that any amendments or modifications shall be 24 authorized under District Council resolution and submitted for prior approval by 25 the Tohono O'odham Legislative Council. 26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15^{TR} 27 day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; 28 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by, 29 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono 30 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -31
