The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 by Resolution No. 20-240, the Legislative Council approved and authorized the FY WHEREAS, 13 2020 Apportionment of Mining Royalties to the districts by equal distribution; 14 and 15 WHEREAS by Sells District Council Resolution No. SD-85-22, the Sells District has authorized 16 and submitted for review and approval the FY 2023 Sells District North 17 Communities Mining Royalties Budget, which is incorporated by this reference, 18 in the amount of \$26,063.17 to be funded by FY 2021 North Communities Mining 19 Royalties Budget carryover funds; and 20 WHEREAS, the Budget and Finance Committee has reviewed the FY 2023 Sells District North 21 Communities Mining Royalties Budget and recommends its approval. 22 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 23 FY 2023 Sells District North Communities Mining Royalties Budget in the amount 24 of \$26,063.17 effective October 1, 2022, which shall be funded by FY 2021 North 25 Communities Mining Royalties carryover funds. 26 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Sells 27 District North Communities Mining Royalties Budget shall be managed and 28 expended in accordance with Article IX, Section 7 of the Constitution of the 29 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 30 modifications shall be authorized under District Council resolution and 31 submitted for prior approval by the Tohono O'odham Legislative Council.
