The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 by Sells District Council Resolution No. SD-86-22, the Sells District has authorized WHEREAS. 13 and submitted for review and approval its FY 2023 Sells District North 14 Communities INT-01-14 Budget, which is incorporated by this reference, in the 15 amount of \$1,621,49; and 16 the Budget and Finance Committee has reviewed the FY 2023 Sells District North WHEREAS, 17 Communities INT-01-14 Budget and recommends its approval. 18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 19 FY 2023 Sells District North Communities INT-01-14 Budget in the amount of 20 \$1,621.49 effective October 1, 2022, which shall be funded by FY 2021 North 21 Communities INT-01-14 carryover funds. 22 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Sells 23 District North Communities INT-01-14 Budget shall be managed and expended in 24 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham 25 Nation and the Nation's laws, provided that any amendments or modifications 26 shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15^{TR} day of <u>SEPTEMBER</u>, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; <u>-0-AGAINST</u>; <u>-0-NOT VOTING</u>; and <u>[02] ABSENT</u>, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
