1 WHEREAS. pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 2 Nation. 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS, by Gu Achi District Council Resolution No. 0622-113, the Gu Achi District has 13 authorized the FY 2023 Gu Achi District Budget, which is incorporated by this 14 reference, in the amount of \$3,932,391,66; and 15 WHEREAS, the Budget and Finance Committee has reviewed the FY 2023 Gu Achi District 16 Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2023 Gu Achi District Budget effective October 1, 2022 in the amount of 19 \$3,932,391.66, which shall be funded by the August 2022 District Gaming 20 Allocation. 21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Gu Achi 22 District Budget shall be managed and expended in accordance with Article IX, 23 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws. 24 provided that any amendments or modifications shall be authorized under 25 District Council resolution and submitted for prior approval by the Tohono 26 O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; _0_ AGAINST; _0_ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
