

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Gu Achi District Pandemic/Virus Infection Budget)**

RESOLUTION NO. 22-348

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Gu Achi District Council Resolution No. 0622-114, the Gu Achi District has
13 authorized the FY 2023 Gu Achi District Pandemic/Virus Infection Budget, which
14 is incorporated by this reference, in the amount of \$266,154.28; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Gu Achi District
16 Pandemic/Virus Infection Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2023 Gu Achi District Pandemic/Virus Infection Budget effective October 1,
19 2022 in the amount of \$266,154.28, which shall be funded by the Gu Achi District
20 Savings Account.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Gu Achi
22 District Pandemic/Virus Infection Budget shall be managed and expended in
23 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
24 Nation and the Nation's laws, provided that any amendments or modifications
25 shall be authorized under District Council resolution and submitted for prior
26 approval by the Tohono O'odham Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
28 **day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
