15	WHEREAS,	by Resolution No. 21-054, the Legislative Council approved the FY 2021 Gu Achi
16		District Mining Royalties Budget in the amount of \$116,524.71, however, the Gu
17		Achi District did not expend any funds and funds remain available for use; and
18	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2023 Gu Achi District
19		Mining Royalties Budget and recommends its approval.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		FY 2023 Gu Achi District Mining Royalties Budget effective October 1, 2022 in the
22		amount of \$116,524.71, which shall be funded by Mining Allocation - Cyprus.
