The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. by Chukut Kuk District Council Resolution No. 2022-31, the Chukut Kuk District 13 Council has authorized the FY 2023 Chukut Kuk District Budget, which is incorporated by this reference, in the amount of \$2,504,558.98; and 14 15 WHEREAS. by Chukut Kuk District Council Resolution No. 2022-32, the Chukut Kuk District 16 has authorized and submitted for review and approval its request to transfer the remaining balance in the amount of \$1,523,088.11 from the August 2022 Chukut 17 18 Kuk District Gaming Allocation amount of \$3,932,391.66 approved by Legislative 19 Council Resolution No. 22-260 to the Chukut Kuk District Savings Account; and 20 WHEREAS. the Budget and Finance Committee has reviewed the FY 2023 Chukut Kuk District Budget and the request to transfer the remaining balance of the August 2022 21 22 Chukut Kuk District Gaming Allocation and recommends approval. 23 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 24 FY 2023 Chukut Kuk District Budget effective October 1, 2022 in the amount of 25 \$2,504,558.98, which shall be funded by: 26 **(1)** August 2022 District Gaming Allocation in the amount of \$2,409,303.55; 27 **(2)** FY 2017 carryover funds in the amount of \$57,668.84; 28 FY 2018 carryover funds in the amount of \$20,802.83; and **(3)** 29 FY 2019 carryover funds in the amount of \$16,783.76. (4) BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the transfer 30 31 of the remaining August 2022 Chukut Kuk District Gaming Allocation in the

amount of \$1,523,088.11 to the Chukut Kuk District Savings Account until a

budget is prepared, provided that any expenditure of these funds shall be subject

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Chukut Kuk District Budget shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20^{TH} day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX. Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
