The management of these funds shall be only by 5 a treasurer or other authorized officer of the district council who has 6 furnished a surety bond satisfactory to the treasurer of the Tohono 7 O'odham Nation, and all expenditures of these funds shall be by checks 8 signed by such treasurer or other authorized officer and the chairman or 9 vice chairman of the district council. 10 11 ; and by Schuk Toak District Council Resolution No. ST-08-29-22-085, the Schuk Toak 12 WHEREAS, District has authorized the FY 2023 Schuk Toak District Budgets, which are 13 incorporated by this reference, in the amount of \$3,932,391.66; and 14 the Budget and Finance Committee has reviewed the FY 2023 Schuk Toak District 15 WHEREAS, **Budgets and recommends approval.** 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 FY 2023 Schuk Toak District Budgets effective October 1, 2022 in the amount of 18 \$3,932,391.66, which shall be funded by the August 2022 District Gaming 19 20 Allocation. BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Schuk 21 Toak District Budgets shall be managed and expended in accordance with Article 22 IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's 23 laws, provided that any amendments or modifications shall be authorized under 24 District Council resolution and submitted for prior approval by the Tohono 25 26 O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
