pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 1 WHEREAS, 2 Nation. 3 No district council shall expend district funds except pursuant to budgets authorized under resolutions of the district council and approved by the 4 5 Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 furnished a surety bond satisfactory to the treasurer of the Tohono 7 O'odham Nation, and all expenditures of these funds shall be by checks 8 signed by such treasurer or other authorized officer and the chairman or 9 10 vice chairman of the district council. ; and 11 by Sif-Oidak District Council Resolution No. SODC 22-113 and 22-128, the Sif-12 WHEREAS, Oidak District has authorized the FY 2023 Gaming Revenue Budget, which is 13 incorporated by this reference in the amount of \$4,115,636.54; and 14 the Budget and Finance Committee has reviewed the FY 2023 Sif-Oidak District 15 WHEREAS. Gaming Revenue Budget and recommends its approval. 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 FY 2023 Sif-Oidak District Gaming Revenue Budget effective October 1, 2022 in the 18 amount of \$4,115,636.54, which shall be funded by the August 2022 District 19 Gaming Allocation in the amount of \$3,932,391.66 and FY 2016, FY 2017, and FY 20 21 2018 Sif-Oidak District surplus funds in the amount of \$183,244.88. BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Sif-Oidak 22 District Gaming Revenue Budget shall be managed and expended in accordance 23 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and 24 the Nation's laws, provided that any amendments or modifications shall be 25 authorized under District Council resolution and submitted for prior approval by 26 27 the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the  $20^{\mathrm{TH}}$ 28 29

day of <u>SEPTEMBER</u>, <u>2022</u> at a meeting at which a quorum was present with a vote of <u>3,218.0</u> FOR; <u>-0- AGAINST</u>; <u>-0- NOT VOTING</u>; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
