9	WHEREAS,	the Agricultural and Natural Resources Committee reviewed the Plan to Create a
10		Mexican Civil Association, which is confidential and incorporated by this
11		reference as Exhibit A; and
12	WHEREAS,	the Agricultural and Natural Resources Committee reviewed the Bylaws and
13		Articles of Incorporation for the Mexican Civil Association, which are confidential
14		and incorporated by this reference as Exhibit B; and
15	WHEREAS,	the Agricultural and Natural Resources Committee recommends authorization
16		of the Plan to Create a Mexican Civil Association as well as approval of the Bylaws
17		and Articles of Incorporation for the Mexican Civil Association.
