RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Two (2) Individuals to Create a Mexican Civil Association)

RESOLUTION NO. 22-364 1 WHEREAS. the Constitution of the Tohono O'odham Nation vests the Legislative Council with 2 the authority "to promote, protect and provide for public health, peace, morals, 3 education and general welfare of the Tohono O'odham Nation and its members" 4 and "to authorize, charter and regulate public or private corporations and 5 associations whether organized for profit, or for non-profit or charitable 6 purposes" (Constitution, Article VI, Section 1(c)(2) and Section 1(b)); and 7 WHEREAS. in accordance with Resolution No. 20-331, the Nation's chairperson and vice 8 chairperson seek approval to create a Mexican civil association; and 9 WHEREAS, the Agricultural and Natural Resources Committee reviewed the Plan to Create a 10 Mexican Civil Association ("Plan"), which is confidential, and recommends that 11 two (2) individuals, whose names shall also remain confidential, be approved to 12 create the Mexican Civil Association and execute the Plan. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council: 14 1. approves the two (2) individuals, whose names shall remain confidential. 15 listed on Exhibit A to create the Mexican Civil Association and undertake 16 all actions necessary to execute their duties under the Plan; and 17 2. requires these individuals to regularly provide an update to the Nation's 18 Agricultural & Natural Resources Committee and the Legislative Council. 19

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27^{TH} day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 2,661.5 FOR; -0- AGAINST; 556.5 [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by, Article VI, Section 1(b) and Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
