

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 184-84, 98-262, 02-569, 04-659, 05-368, 06-222, 08-035 and 22-253 to Correct Names and/or Enrollment Numbers of Enrolled Members)

RESOLUTION NO. 22-370

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2, and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance); and

13 **WHEREAS,** the Enrollment Committee has determined that a number of resolutions
14 approving membership and adoption applications misspelled or incorrectly
15 listed the names of Nation's members and/or incorrectly listed enrollment
16 numbers; and

17 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 184-84, 98-262,
18 02-569, 04-659, 05-368, 06-222, 08-035 and 22-253 be amended to reflect the
19 correct name and/or enrollment number for the Nation's members identified in
20 the October 2022 Corrected Enrollment Resolution Summary, which is
21 incorporated by this reference.

22 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
23 Nos. 184-84, 98-262, 02-569, 04-659, 05-368, 06-222, 08-035 and 22-253 are
24 amended upon the effective date of those resolutions to reflect the correct name
25 and/or enrollment number of Nation's members identified in the October 2022
26 Corrected Enrollment Resolution Summary.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH
28 day of **OCTOBER, 2022** at a meeting at which a quorum was present with a vote of 2,975.4 FOR;
29 ~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 242.6[06] ABSENT, pursuant to the powers vested in the
30 Council by, Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the
31 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and
32 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
33 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
