9		Services Title XX Block Grant pursuant to Resolution No. 19-250, ADES Contract
10		number DI 20-002237; and
11	WHEREAS,	Amendment No. 1 was approved by Resolution No. 20-236, Amendment No. 2 was
12		approved by Resolution No, 21-134, and Amendment No. 3 extends the IGA from
13		July 1, 2022 to June 30, 2023; and
14	WHEREAS,	the Department of Education has submitted for review and approval Amendment
15		No. 3 to the IGA, which is incorporated by this reference, for the period of July 1,
16		2022 through June 30, 2023, which will not change the reimbursement ceiling of
17		104,203.00; and
18	WHEREAS,	the Human Resources Development Committee has reviewed Amendment No. 3
19		to the Arizona Department of Economic Security Planned Social Services Title XX
20		Block Grant Intergovernmental Agreement and recommend its approval.
21	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
22		accepts the Amendment No.3 to the Arizona Department of Economic Security
