The management of these funds shall be only 6 by a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 : and 12 WHEREAS, by San Lucy District Council Resolution No. 03-47-22, the San Lucy District has 13 authorized the FY 2021-2024 San Lucy District American Rescue Plan Act Budget, 14 which is incorporated by this reference, in the amount of \$3,125,819.00; and 15 WHEREAS, the Budget and Finance Committee has reviewed the FY 2021-2024 San Lucy 16 District American Rescue Plan Act Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2021-2024 San Lucy District American Rescue Plan Act Budget in the amount of 19 \$3,125,819.00 effective March 11, 2021 to December 31, 2024, which shall be 20 funded by American Rescue Plan Act funds. 21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021-2024 San 22 Lucy District American Rescue Plan Act Budget shall be managed and expended 23 in accordance with Article IX, Section 7 of the Constitution of the Tohono 24 O'odham Nation and the Nation's laws, provided that any amendments or 25 modifications shall be authorized under District Council resolution and 26 submitted for prior approval by the Tohono O'odham Legislative Council. 27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11^{TR} 28
