1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power to "consult,
2		negotiate and conclude agreements and contracts on behalf of Tohono O'odham
3		Nation with Federal, State and local governments and other Indian tribes or their
4		departments, agencies, or political subdivisions, or with private persons or
5		organizations on all matters within the authority of the Tohono O'odham
6		Council" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and
7	WHEREAS,	by Resolution No. 21-398, the Legislative Council approved the FY 2022
8		Governmental Relations Representation Contract with Veridus (the "Contract"),
9		with an initial term from October 1, 2021 to September 30, 2022; provided that the
10		Contract automatically renews "for a maximum of two additional one year terms
11		unless either party gives 30 days' written notice prior to October 1 of intent not to
12		renew the Contract." (Contract, Section 13.1); and
13	WHEREAS,	the Legislative Council has approved the FY 2023 Executive Branch Economic
14		Development Delegation/Gaming Negotiation Committee Budget, which
15		includes funding for professional and lobbying services; and
16	WHEREAS,	the Economic Development Delegation and Appropriations Committee continue
17		to recommend that the Veridus firm be retained as a governmental relations
18		consultant for matters involving legislative, administrative, lobbying, and agency
19		activities in the State of Arizona, as well as related local and municipal
20		governmental activities that may affect the Nation, in accordance with the
21		Contract as amended by the FY 2023 Governmental Relations Representation
22		Contract Amendment, which is incorporated by this reference.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
24		1. approves the FY 2023 Governmental Relations Representation Contract
25		Amendment effective October 1, 2022, which shall be funded by the FY 2023
26		Economic Development Delegation/Gaming Negotiating Committee Budget;

28		2. authorizes the Nation's chairperson to execute the FY 2023 Governmental
