RESOLUTION NO. 22-389

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2, and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption (14 Tohono O'odham Code Chapter 1 – Enrollment Ordinance); and**

13 **WHEREAS, the Enrollment Committee has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-80, 46-80, 128-**
17 **80, 127-83, 97-144, 98-294, 01-416, 02-332, 03-301, 03-463, 05-114, 05-204, 07-112,**
18 **08-682, 09-477, 11-229, 17-538, and 22-315 be amended to reflect the amended**
19 **names for the Nation's members identified in the November 2022 Amended**
20 **Enrollment Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 15-80, 46-80, 128-80, 127-83, 97-144, 98-294, 01-416, 02-332, 03-301, 03-463,**
23 **05-114, 05-204, 07-112, 08-682, 09-477, 11-229, 17-538, and 22-315 are amended**
24 **upon the effective date of those resolutions to reflect the legal name changes of**
25 **Nation's members identified in the November 2022 Amended Enrollment**
26 **Resolution Summary.**
