9		Ordinance); and
10	WHEREAS,	pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11		O'odham Legislative Council shall determine eligibility for membership or
12		adoption (14 Tohono O'odham Code Chapter 1 – Enrollment Ordinance); and
13	WHEREAS,	the Enrollment Committee has determined that a number of resolutions
14		approving membership and adoption applications misspelled or incorrectly
15		listed the names of Nation's members; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 05-148, 05-204, 05-
17		368, 06-222, 06-511, 07-075, 07-236, 07-739, 08-324, 10-153, 11-402, 12-085, and 22-
18		313 be amended to reflect the correct names for the Nation's members identified
19		in the November 2022 Corrected Enrollment Resolution Summary, which is
20		incorporated by this reference.
