13		mutual aid and assistance in the field of law enforcement; and
14	WHEREAS,	the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid
15		Agreement Between the Tohono O'odham Nation and the City of Peoria and
16		recommends its approval.
