

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Baboquivari District Administration Budget Amendment No. 1, FY 2023 South Komelic Community Budget, FY 2023 Artesia/Little Tucson Community Budget, and FY 2023 Artesia/Little Tucson Community Building Project Budget)

RESOLUTION NO. 22-395

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2023 Baboquivari District Administration and Community Budgets in the
13 amount of \$3,932,391.66 were authorized by Baboquivari District Council
14 Resolution No. 2022-B-83 and approved by Legislative Council Resolution No. 22-
15 353; and

16 **WHEREAS,** by Baboquivari District Council Resolution Nos. 2022-B-101, 2022-B-96, 2022-B-
17 99, and 2022-B100, the Baboquivari District has authorized and submitted for
18 review and approval the following budgets, which are incorporated by these
19 references:

- 20 1. FY 2023 Baboquivari District Administration Budget Amendment No. 1;
- 21 2. FY 2023 South Komelic Community Budget;
- 22 3. FY 2023 Artesia/Little Tucson Community Budget;
- 23 4. FY 2023 Artesia/Little Tucson Community Building Project Budget; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Baboquivari
25 District Administration Budget Amendment No. 1, FY 2023 South Komelic
26 Community Budget, FY 2023 Artesia/Little Tucson Community Budget, and FY
27 2023 Artesia/Little Tucson Community Building Project Budget and recommends
28 approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
30 FY 2023 Baboquivari District Budgets effective October 1, 2022 as follows:

- (1) **FY 2023 Baboquivari District Administration Budget Amendment No. 1, which includes a \$915,224.78 decrease from \$2,091,942.10 to \$1,176,717.32;**
- (2) **FY 2023 South Komelic Community Budget in the amount of \$457,612.39, which shall be funded by the FY 2023 Baboquivari District Administration Budget Amendment No. 1;**
- (3) **FY 2023 Artesia/Little Tucson Community Budget in the amount of \$457,612.39, which shall be funded by the FY 2023 Baboquivari District Administration Budget Amendment No. 1; and**
- (4) **FY 2023 Artesia/Little Community Building Project Budget in the amount of \$1,136,298.86, which shall be funded by FY 2022 Artesia/Little Tucson Community Building Project carryover funds.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Baboquivari District Budgets as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day of **NOVEMBER, 2022** at a meeting at which a quorum was present with a vote of **3,001.4 FOR; -0- AGAINST; -0- NOT VOTING; and 216.6 [05] ABSENT**, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
