

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Accepting the Arizona Department of Economic Security for Workforce Innovation and Opportunity Act Title 1B Intergovernmental Agreement Amendment No. 1)

RESOLUTION NO. 22-396

1 **WHEREAS, the Tohono O'odham Council vests the Legislative Council with the power "to**
2 **consult, negotiate, and conclude agreements and contracts on behalf of the**
3 **Tohono O'odham Nation with Federal, State and local governments and other**
4 **Indian tribes or their departments, agencies, or political subdivisions, or with**
5 **private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council" (Constitution of the Tohono O'odham Nation Article**
7 **VI, Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation has negotiated an Intergovernmental Agreement**
9 **("IGA") with the Arizona Department of Economic Security for Workforce**
10 **Innovation and Opportunity Act ("WIOA") Title 1B pursuant to Resolution No. 21-**
11 **343, ADES Contract number DI21-002302; and**

12 **WHEREAS, the Department of Education has submitted for review and approval the Arizona**
13 **Department of Economic Security WIOA Title 1B IGA Amendment No. 1, which is**
14 **incorporated by this reference, for the period of April 01, 2021 through June 30,**
15 **2023, which will increase the contract reimbursement ceiling by \$680,774.00**
16 **from \$861,386.00 to \$1,542,160.00; and**

17 **WHEREAS, the Human Resources Development Committee has reviewed the Arizona**
18 **Department of Economic Security WIOA Title 1B IGA Amendment No. 1 and**
19 **recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
21 **accepts the Arizona Department of Economic Security for Workforce Innovation**
22 **and Opportunity Act Title 1B Intergovernmental Agreement Amendment No. 1.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to execute**
25 **Amendment No. 1, provided however, that any further amendments or**
26 **modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
29 **day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,001.4 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and 216.6 [05] ABSENT, pursuant to the powers vested in the**
31 **Council by, Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
