

**RESOLUTION OF THE TOHONO O’ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of
Senior Services Title III Budgets Amendments No. 1)**

RESOLUTION NO. 22-400

1 **WHEREAS,** the Tohono O’odham Legislative Council is authorized “to manage any funds
2 within the exclusive control of the Tohono O’odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members” provided that “[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets”
5 authorized by resolution or ordinance (Constitution of the Tohono O’odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2023 Department of Health and Human Services (“DHHS”) Division of
8 Senior Services B-1 Transportation Budget and C-1 Congregate Budget
9 (collectively, “Title III Budgets”) were approved by Resolution No. 22-168; and

10 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2023
11 Division of Senior Services Title III Budgets Amendments No. 1, which are
12 incorporated by this reference, and which will adjust personnel and/or
13 operational line items; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
15 reviewed the FY 2023 DHHS Division of Senior Services Title III Budgets
16 Amendments No. 1 and recommend their approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O’odham Legislative Council approves the
18 FY 2023 Department of Health and Human Services Division of Senior Services
19 Title III Budgets Amendments No. 1 effective July 1, 2022, as follows:

- 20 1. B-1 Transportation Budget will remain the same at \$17,306.00.
- 21 2. C-1 Congregate Budget will remain the same at \$45,476.00.

22 **BE IT FINALLY RESOLVED** by the Tohono O’odham Legislative Council that the Tohono O’odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2023 Department of Health and Human Services Division of Senior
25 Services Title III Budgets: B-1 Transportation as amended; C-1 Congregate as
26 amended, provided that any further amendments or modifications shall be
27 submitted for prior approval by the Tohono O’odham Legislative Council.

28 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 16TH**
29 **day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
30 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(d) (2) and (3) of the Constitution of the Tohono O’odham Nation, adopted by**
32 **the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**




