

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Title VI
Medicare Improvements for Patients and Providers Act Grant Budget)**

RESOLUTION NO. 22-402

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2023 Division of Senior Services Title VI Medicare
9 Improvements for Patients and Providers Act (MIPPA) Grant Budget, which is
10 incorporated by this reference, in the amount of \$9,850.00 to be funded by the
11 Nation's general fund pending reimbursement by the grantor, the Department of
12 Health and Human Services Administration for Community Living; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2023 Department of Health and Human Services Title VI Medicare
15 Improvements for Patients and Providers Act Grant Budget and recommend its
16 approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2023 Department of Health and Human Services Title VI Medicare
19 Improvements for Patients and Providers Act Grant Budget effective September
20 1, 2022, in the amount of \$9,850.00, which shall be funded by the Nation's general
21 fund pending reimbursement from the grantor, the Department of Health and
22 Human Services Administration for Community Living.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2023 Department of Health and Human Services Title VI Medicare
26 Improvements for Patients and Providers Act Grant Budget, provided that any
27 amendments or modifications shall be submitted for prior approval by the
28 Tohono O'odham Legislative Council.






