

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023-FY 2024 Department of Health and Human Services Title  
VI Public Health Workforce Grant Budget)**

**RESOLUTION NO. 22-403**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2023 - FY 2024 Title VI Public Health Workforce Grant  
9 Budget, which is incorporated by this reference, in the amount of \$80,000.00 to be  
10 funded by the Nation's general fund pending reimbursement by the grantor, the  
11 Department of Health and Human Services Administration for Community  
12 Living; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
14 reviewed the FY 2023 - FY 2024 Department of Health and Human Services Title VI  
15 Public Health Workforce Grant Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2023 - FY 2024 Department of Health and Human Services Title VI Public  
18 Health Workforce Grant Budget effective January 1, 2022 ending September 30,  
19 2024, in the amount of \$80,000.00, which shall be funded by the Nation's general  
20 fund pending reimbursement from the grantor, the Department of Health and  
21 Human Services Administration for Community Living.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
23 Nation chairperson or any designated official is authorized to administer and  
24 expend the FY 2023 - FY 2024 Department of Health and Human Services Title VI  
25 Public Health Workforce Grant Budget, provided that any amendments or  
26 modifications shall be submitted for prior approval by the Tohono O'odham  
27 Legislative Council.


28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
29 **day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,**  
31 **Article VI, Section 1(d) (2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**


