11	WHEREAS,	the Department of Health and Human Services Management of Health has
12		received a no cost extension notice from the Department of Health and Human
13		Services to extend the CDC Capacity Grant award through June 9, 2023; and
14	WHEREAS,	the Health and Human Services and Budget and Finance Committees reviewed
15		and recommends accepting the no cost extension for the FY 2023 Department of
16		Health and Human Services Management of Health CDC Capacity Budget and
17		approving the extension of the budget term through June 9, 2023.
