

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting a No Cost Extension for the Budget Term of the FY 2021 Department of Health and Human Services Center for Disease Control and Prevention Supporting Tribal Public Health Capacity and approving an Extension of the Budget Term into FY 2023)**

RESOLUTION NO. 22-407

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section I (d) (2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Management of Health
8 CDC Capacity Grant Budget in the amount of \$810,968.00 was approved by
9 Resolution No. 21-192 and the budget period was extended to June 9, 2022 by
10 Resolution No. 21-471; and

11 **WHEREAS,** the Department of Health and Human Services Management of Health has
12 received a no cost extension notice from the Department of Health and Human
13 Services to extend the CDC Capacity Grant award through June 9, 2023; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees reviewed
15 and recommends accepting the no cost extension for the FY 2023 Department of
16 Health and Human Services Management of Health CDC Capacity Budget and
17 approving the extension of the budget term through June 9, 2023.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
19 no cost extension of the CDC Capacity Grant and approves the extension of the
20 budget term of the FY 2023 Department of Health and Human Services
21 Management of Health CDC Capacity Budget beginning June 10, 2020 ending June
22 9, 2023.

23 **BE IT FINALLY RESOLVED** that Tohono O'odham Legislative Council authorizes the Tohono
24 O'odham Nation chairperson or any designated official to administer and expend
25 the FY 2023 Department of Health and Human Services Management of Health
26 CDC Capacity Grant, provided that any amendments or modifications shall be
27 submitted for prior approval by the Tohono O'odham Legislative Council.




