(Amending Enrollment Resolution Nos. 74-83, 83-83, 98-83, 184-83, 782-85, 193-88,
91-161, 93-238, 98-174, 08-100, 08-324, 20-001, 21-338 and 21-382 to Reflect
Legal Name Changes of Enrolled Members)

RESOLUTION NO. 22-418

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**


13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 74-83, 83-83, 98-83,**
17 **184-83, 782-85, 193-88, 91-161, 93-238, 98-174, 08-100, 08-324, 20-001, 21-338 and**
18 **21-382 be amended to reflect the amended names of members identified in the**
19 **December 2022 Amended Enrollment Resolution Summary, which is**
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 74-83, 83-83, 98-83, 184-83, 782-85, 193-88, 91-161, 93-238, 98-174, 08-100, 08-**
23 **324, 20-001, 21-338 and 21-382 are amended upon the effective date of those**
24 **resolutions to reflect the legal name changes of members identified in the**
25 **December 2022 Amended Enrollment Resolution Summary.**


26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**


