

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 21-333, "Approving FY 2022 Planning and Economic
Development Department Roads Program Road Safety Assessment for BIA
Route 19 Budget" through FY 2024)**

RESOLUTION NO. 22-432

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . , and to appropriate
3 these funds for the benefits of the nation and its members" provided that "(a)ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
8 Road Safety Assessment for BIA Route 19 Budget in the amount of \$99,974.46 was
9 approved by Resolution No. 21-333 in which the budget authority expires on
10 September 30, 2022; and

11 **WHEREAS,** the Bureau of Indian Affairs Western Region Office awarded the Nation a no-cost
12 extension for Road Safety Assessment BIA Route 19 to September 30, 2024; and

13 **WHEREAS,** the Planning and Economic Development Department Roads Program has
14 submitted for review and approval its FY 2023 Road Safety Assessment for BIA
15 Route 19 Budget requesting to amend Resolution No. 21-333 to extend the budget
16 period through September 30, 2024 to allow for available funds to be expended;
17 and

18 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
19 have reviewed and recommend its approval of the FY 2023 Planning and
20 Economic Development Department Roads Program Road Safety Assessment for
21 BIA Route 19 Budget extension through September 30, 2024.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves an
23 extension of the budget authority for the FY 2023 Planning and Economic
24 Development Department Roads Program Road Safety Assessment for BIA Route
25 19 Budget in the amount of \$99,974.46 through September 30, 2024.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend FY 2023 Planning and Economic Development Department Roads
29 Program Road Safety Assessment for BIA Route 19 Budget, for the period of
30 October 1, 2022 through September 30, 2024 and the Accounting Office is
31 authorized to post the unexpended balances of the budget as of September 30,


