

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation's "Amended 2022 Indian Housing Plan")**

RESOLUTION NO. 22-436

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power to enact laws "to promote, protect and provide for public health, peace,
3 morals education and general welfare of the Tohono O'odham Nation and its
4 members" (Constitution, Article VI, Section 1(c)(2)); and

5 **WHEREAS,** the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6 designated housing entity in accordance with the Native American Housing
7 Assistance and Self-Determination Act of 1996, 25 U.S.C. §4101, et seq., P.L. 104-
8 330, 110 Stat. 4016 ("NAHASDA"); and

9 **WHEREAS,** to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA
10 requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe
11 or by the tribe's designated housing entity (25 U.S.C. §4112); and

12 **WHEREAS,** pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,
13 Chapter 1, the TOKA shall submit annually to the United States Department of
14 Housing and Urban Development's Southwest Area Office of Native American
15 Programs ("SWONAP") the Nation's Indian Housing Plan after review and
16 approval by Legislative Council resolution (TOKA Ordinance, Article IX, 1.,
17 <http://tolc-nsn.org/docs/Title18Ch1.pdf>); and

18 **WHEREAS,** the Tohono O'odham Nation 2022 Indian Housing Plan was approved by
19 Legislative Council Resolution No. 22-053; and

20 **WHEREAS,** TOKA prepared and submitted the Nation's Amended 2022 Indian Housing Plan
21 for the program year beginning July 1, 2022 and ending June 30, 2023 to TOKA's
22 Board of Directors for review and approval (TOKA Ordinance, Article IX, 1, b., ii.)
23 to include the Title VI Loan; and

24 **WHEREAS,** after the TOKA Board of Directors approved the Nation's Amended 2022 Indian
25 Housing Plan by Resolution No. 11-06-22, the TOKA's Board of Directors provided
26 the IHP to the Legislative Housing Committee for review and approval (TOKA
27 Ordinance, Article IX, 1, b., iii.); and

28 **WHEREAS,** the Legislative Housing Committee recommends approval of the Nation's
29 Amended 2022 Indian Housing Plan for the program year beginning July 1, 2022
30 and ending June 30, 2023, which includes the additional funding source of the
31 Title VI Loan.



1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
2 Nation's Amended 2022 Indian Housing Plan, provided that any additional
3 amendments are subject to Legislative Council review and approval.


4 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the
5 Nation's Chairperson to sign the certification authorizing submission by the
6 TOKA of the Nation's Amended 2022 Indian Housing Plan.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
8 day of DECEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,001.4 FOR;
9 -0- AGAINST; -0- NOT VOTING; and 216.6[05] ABSENT, pursuant to the powers vested in the
10 Council by, Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted
11 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
12 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
13 Act of June 18, 1934 (48 Stat.984).
