

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation 2023 Indian Housing Plan)**

RESOLUTION NO. 22-437

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power to enact laws "to promote, protect and provide for public health, peace,
3 morals education and general welfare of the Tohono O'odham Nation and its
4 members" (Constitution, Article VI, Section 1(c)(2)); and

5 **WHEREAS,** the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6 designated housing entity in accordance with the Native American Housing
7 Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, *et seq.*, P.L.
8 104-330, 110 Stat. 4016 ("NAHASDA"); and

9 **WHEREAS,** to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA
10 requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe
11 or by the tribe's designated housing entity (25 U.S.C. § 4112); and

12 **WHEREAS,** pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,
13 Chapter 1, the TOKA is required to submit the Nation's IHP annually to the United
14 States Department of Housing and Urban Development's Southwest Area Office of
15 Native American Programs ("SWONAP") after review and approval by Legislative
16 Council resolution (TOKA Ordinance, Article IX, Section 1); and

17 **WHEREAS,** under the direction of the TOKA's executive director, the TOKA prepared and
18 submitted the Nation's 2023 IHP for the program year beginning July 1, 2023 and
19 ending June 30, 2024 to TOKA's Board of Directors for review and approval (TOKA
20 Ordinance, Article IX, Section 1(b)(ii)); and

21 **WHEREAS,** after approving the Nation's 2023 IHP for the program year beginning July 1, 2023
22 and ending June 30, 2024 by Resolution No. 10-03-22, the TOKA's Board of
23 Directors provided the IHP to the Legislative Housing Committee for review and
24 approval (TOKA Ordinance, Article IX, Section 1(b)(iii)); and


25 **WHEREAS,** the Legislative Housing Committee reviewed and recommends approval of the
26 Nation's 2023 IHP for the program year beginning July 1, 2023 and ending June 30,
27 2024.

28 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it approves
29 and authorizes the submittal of the Nation's 2023 Indian Housing Plan for the
30 program year beginning July 1, 2023 and ending June 30, 2024, provided that any
31 amendments are subject to Legislative Council review and approval.

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that it authorizes the
2 Nation's chairperson to sign the certification authorizing submission by the
3 TOKA of the Nation's 2023 Indian Housing Plan for the program year beginning
4 July 1, 2023 and ending June 30, 2024 to the United States Department of Housing
5 and Urban Development's Southwest Area Office of Native American Programs.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
7 day of DECEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
8 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,
9 Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
10 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).
