

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement Between the Tohono O'odham
Nation and Easy Livin', LLC)

RESOLUTION NO. 22-440

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "consult,
2 negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation
3 with Federal, State and local governments . . . or their departments, agencies, or
4 political subdivisions, or with private persons or organizations on all matters
5 within the authority of the Tohono O'odham Council"; to "promote, protect and
6 provide for public health, peace, morals, education and general welfare of the
7 Tohono O'odham Nation and its members"; "to manage any funds within the
8 exclusive control of the Tohono O'odham Nation . . . and to appropriate these
9 funds for the benefit of the [N]ation and its members; and "to adopt, approve and
10 amend annual budgets and to authorize the expenditure of funds in accordance
11 with these budgets" (Constitution of the Tohono O'odham Nation, Article VI,
12 Sections 1(f), 1(c)(2), 1(d)(2) and 1(d)(3)); and

13 **WHEREAS,** the Tohono O'odham Nation has negotiated a new Professional Services
14 Agreement Between the Tohono O'odham Nation and Easy Livin', LLC which will
15 allow Easy Livin', LLC to provide residential and foster care services for the
16 Nation's minor children under the custody of the Nation's Health and Human
17 Services Department Child Welfare Services Division; and

18 **WHEREAS,** the budget for the Professional Services Agreement Between the Tohono
19 O'odham Nation and Easy Livin', LLC exceeds \$500,000; and

20 **WHEREAS,** the funding for the Professional Services Agreement Between the Tohono
21 O'odham Nation and Easy Livin', LLC will come from the FY 2022 Department of
22 Health and Human Services Division of Child Welfare Services Tribal Child
23 Welfare Budget 001-23-6051; and

24 **WHEREAS,** the Health and Human Services Committee has reviewed the Professional
25 Services Agreement Between the Tohono O'odham Nation and Easy Livin', LLC
26 and recommends its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 Professional Services Agreement Between the Tohono O'odham Nation and Easy
29 Livin', LLC.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
31 Nation chairperson or any designated official is authorized to execute the
32 Professional Services Agreement Between the Tohono O'odham Nation and Easy



2 amendments shall be submitted for prior approval by the Tohono O'odham

6 95.25 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council
7 by, Article VI, Section 1(f), 1(c)(2), 1(d)(2) and 1(d)(3) of the Constitution of the Tohono O'odham
8 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
9 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
10 16 of the Act of June 18, 1934 (48 Stat.984).
