RESOLUTION NO. 23-001

1	WHEREAS,	Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2		Tohono O'odham Legislative Council with the power to "enact laws and
3		ordinances governing the enrollment and adoption of members and the
4		relinguishment and loss of membership"; and
5	WHEREAS,	in accordance with the Tohono O'odham Nation Enrollment Ordinance,
6		Ordinance No. 05-81 as amended, the Enrollment Committee has reviewed and
7		recommended approval of the enrollment or adoption applications for the
8		individuals identified in the January 2023 Membership Applications List, which is
9		incorporated by this reference; and
10	WHEREAS,	pursuant to Article VIII, Section 1 (C) (1) and (2) of the Enrollment Ordinance:
11		The final determination to approve or reject an application for
12		membership or adoption shall be recorded in a Council resolution. Each
13		determination shall set forth the following findings of fact:
14		(1) If an application for adoption is approved, the applicant's date of
15		birth, the degree of Papago-Tohono O'odham Indian Blood
16		ascribed to the applicant, and the Enrollment Committee's
17		recommendation that the application be approved or rejected;
18		(2) If an application for membership is approved, the applicant's date
19		of birth, the membership requirement which Council determined
20		that the applicant established, and the Enrollment Committee's
21		recommendation that the application be approved or rejected.
22	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed
23		the Enrollment Committee's recommendations and approves the applications
24		for enrollment or adoption that are identified in the January 2023 Membership
25		Applications List which includes the name, date of birth, enrollment number, and
26		membership requirement or, for adoption, the degree of Papago-Tohono
27		O'odham Indian blood for each applicant.
