1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 114-80, 06-81, 122-82,**
17 **136-82, 150-82, 74-83, 127-83, 184-83, 197-83, 09-85, 58-85, 340-86, 66-89, 142-89,**
18 **308-89, 24-90, 93-305, 93-056, 93-360, 93-402, 95-139, 95-518, 96-077, 97-036, 97-**
19 **256, 98-034, 98-123, 02-508, 05-426, 05-472, 07-007, 09-330, 13-331, 13-431, 15-389,**




