14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 83-83, 26-86, 91-161,
17		01-263, 01-589, 05-002, 05-054, 05-204, 05-301, 05-711, 06-059, 08-005, 08-035, 08-
18		330, 08-644, 09-008, 13-063, and 22-390 be amended to reflect the correct names

20		Summary, which is incorporated by this reference.
